

## 2024 NOMINATION FORM HISTORIC FORT WORTH'S MOST ENDANGERED PLACES

HFW's List of Most Endangered Places is a marketing and educational tool that spotlights historic resources threatened by a variety of circumstances including deterioration, neglect, vandalism, encroachment, loss of parking, development, lack of financial resources, etc. A wide range of sites will be considered for the 2024 list including commercial, residential, religious, public buildings, neighborhoods, bridges, monuments and landscapes. Owners of properties recognized as *Most Endangered* benefit from increased public awareness and solutions.
